

LINCOLN COUNTY AMBULANCE DISTRICT

PUBLIC HEARING NOTICE

TAKE NOTICE that the Lincoln County Ambulance District, Lincoln County, Missouri will hold a public hearing on Wednesday, August 19, 2026, at the hour of 6:30 P.M. at the Administration Building, 1392 S. Third Street, Troy, Missouri 63379, within the said District, at which meeting residents of said District may be heard concerning the property tax rates proposed to be set by said District. The tax rates shall be set to produce revenues which the budget for the fiscal year beginning January 1, 2027, shows to be required from property tax after all adjustments are made to conform to the provisions of Sec.'s 137.073, 137.115, 113.245 and 67.110 RsMo., and Article X, Sec 22 of the Missouri Constitution.

The tax rate is determined by dividing the amount of revenue required by the current tax year assessed valuation (less any tax increment finance district and sales tax by Missouri State statutes). The result is multiplied by 100 so the tax rate will be expressed in cents per \$100.00 of assessed valuation.

The tax rates outlined herein are merely proposed and subject to increase or decrease when final figures are received by the District. The final tax levy to be set by the District shall be established in accordance with the provisions of Sec.'s 137.073, 137.115, 113.245 and 67.110 RsMo., and Article X, Sec 22 of the Missouri Constitution and said determinations shall be made in accordance with the District's tax calculations which shall be available at the public hearing.
